Guidelines for conduct of online examination:

1. The Examination for theory paper will be through online mode with use of Pen and Paper. The Questions of the respective Paper will be sent to the students before 15 minutes of the commencement of the Examination, through the WhatsApp group created for the Examination purpose.
2. The duration of each paper of Examination is two hours (mentioned on question). The students will write the answer at home within 2 hours and answer must be written around 200 words. The students are instructed to scan and create a pdf file of his/her answer and mail the same to the College ID-blslawcollege@gmail.com. 30 minutes extra time will be given for the scanning, creating pdf and sending pdf file to College mail. After 30 minutes no answer scripts will be accepted.
3. The Questions are in traditional pattern as in the previous Semester examinations. The students are advised to write with black ball pen on a good quality white A4 size paper. The answer must be limited 6 pages or 3 sheets.
4. The front page of the answer sheet should as per the format uploaded in the group. At the top of every other pages (Page no.2 to Page no.6) as per format. The candidate should mention (i) Page No. (ii) Roll No. (iii) Subject and (iv) Paper. There may be one inch margin on the left and top of every page, by making margin line.
5. Identical answers of students by group sharing of answers using any kind of digital technique or other methods will be treated as malpractice. All are advised to write answers at home individually and ensure that the answers are just not copied from book. Be precise and use your own version and words for getting better score in the examination.
6. Surprise online invigilation may be done at any time during the examination by WhatsApp video calling or any other means.
7. The students are advised to acquaint with creating pdf file. The PDF file will be saved with your Exam Roll No. of the Student. The hard copy of answer script and soft copy of each paper must be saved/ preserved until publication of result by the student.
8. A sample Blank answer sheet of 6 pages including cover page is upload in WhatsApp group and also in College website. The students may download the format for their convenience.
